TOOLXX	Positive list of technologies	New tool to address periodic assessment and update of the positive lists contained in several methodologies.

ACM0003		The MP seeks a mandate to revise ACM0003 and other relevant small scale methodologies to introduce reference to "TOOL16: Project and leakage emissions from biomass".
AM0031	Bus rapid transit projects	The MP seeks a mandate to revise AM0031 as the methodology does not cover situations where there are changes to the number of vehicles retired as a result of the increase in the poluplation and consequent increase in the demnad for buses.
AM_CLA_ 0279	Abatement of	Clarification request whether ACM008 allows for the extraction of methane from a virgin coal bed BEFORE the mining activity starts.

TOOL19		Positive lists have been introduced replacing the unit size thresholds. The cover note contains an analysis on the applicability to SMEs.

However, the MP has found that the methodology is not compatible with the tool.
-	Mandate for new methodology	The MP has been working on a revision to "AMS-III.BK: Strategic feed supplementation in smallholder dairy sector to increase productivity" for several meetings and has come to the conclusion that a new methodology rather than a revision of AMS-III.BK would be more appropriate.

SSC_742	Clarification on the units used in the fNRB calculation under TOOL30	The enquirer is a project participant who sought clarification on the following two issues:  a) (Issue 1) Whether a questionnaire survey can be used to monitor utilization hours under Option 1 of AMS-II.G;  b) (Issue 2) Whether cubic meters instead of tonnes can be used in the calculation of fraction of non-renewable biomass under TOOL30.
SSC_743	Validity of the results of the annually made monitoring surveys like Kitchen Performance Test (KPT)	The proponent sought clarification on several monitoring aspects of "AMS-II.G: Energy efficiency measures in thermal applications of non-renewable biomass" (ver.5).
